NON-CIRCUMVENTION AGREEMENT

This Agreement is made and agreed this _____ day of _____, _____ by and between **Rising Bird, Inc.** and _____, hereinafter referred to as "Client".

Whereas, part of those services may require that Client contact or receive information concerning others, hereinafter referred to as "Third Parties", originated, created, and provided by and through the efforts of Rising Bird, Inc; and

Whereas, Rising Bird, Inc desires to create and originate those contacts and information with Third Parties for Client so long as Client does not deal directly with Third Parties to the detriment of Rising Bird, Inc; and

Whereas, the Client is willing to provide security to Rising Bird, Inc for that purpose.

Now, Therefore, in consideration of the covenants and conditions set forth herein, the parties agree as follows.

- _____ **Initial** 1. The Client agrees that Client shall not contact nor receive information on Third Parties provided by Rising Bird, Inc for the purpose of funding without the knowledge or to the exclusion of Rising Bird, Inc. The Third Parties include but are not limited to affiliates, funding sources, investment broker dealers, consultants, and the like.
- _____ **Initial** 2. Client shall not enter into business relations or contacts with Third Parties provided by Rising Bird, Inc without the express written consent of Rising Bird, Inc and without providing for compensation acceptable to Rising Bird, Inc.

Moreover, the names and identities of all Third Parties must remain confidential under this agreement, and Client agrees not to disclose to any Third Parties or to any other persons or entities the names or identities of any other Third Parties.
